TERMS & CONDITIONS

1/ ORGANISATION

CERAMIC Network 2020, hereinafter referred to as “the Event”, is organised by the Pôle Européen de la Céramique (European cluster of Ceramics), an association whose registered head office is located at 1, avenue d’Ester 87069 Limoges – France, hereinafter referred to as “the Organiser”.

1/ L’ORGANISATION

CERAMIC Network 2020, ci-après dénommé “l’Événement”, est organisé par le Pôle Européen de la Céramique, association dont le siège social est situé au 1, avenue d’Ester 87069 Limoges - France, ci-après dénommée “l’Organisateur”.

2/ PURPOSE

These regulations stipulate the terms and conditions according to which the Organiser sets up and runs the Event. They detail the respective rights and obligations of the Organiser and the signatory, hereafter referred to as “the Participant”. The Participant formally undertakes to comply with these regulations.

2/ OBJET

Ce règlement précise les modalités selon lesquelles l’Organisateur met en place et gère la Manifestation. Il détaille les droits et obligations respectifs de l’Organisateur et du signataire, ci-après dénommé “le Participant”. Le Participant s’engage formellement à respecter ce règlement.

3/ PLACE AND DATE

The Event will be held in the Zenith of Limoges (Limoges - France), on June 10th & 11th 2020. The Organiser is free to change the place or date of the event in case of unavailability or force majeure. The organiser is free to cancel the meeting with prior notification made to the Participant. In such event, registered applications will be cancelled, without compensation, except for the refund of pre-paid registration fees.

3/ LIEU ET DATE

L’événement aura lieu au Zénith de Limoges (Limoges - France), les 10 et 11 juin 2020. L’Organisateur est libre de modifier le lieu ou la date de l’événement en cas d’indisponibilité ou de force majeure. L’organisateur est libre d’annuler la réunion avec notification préalable au Participant. Dans ce cas, les inscriptions enregistrées seront annulées, sans compensation, à l’exception du remboursement des frais d’inscription prépayés.

4/ ADMISSION, REGISTRATION, PAYMENT AND CANCELLATION

Any company or institution is entitled to participate to the Event provided it has the relevant skills in the ceramic field. The Organiser reserves the right to deny any application without any obligation to justify its decision.

The registration form must be completed and signed by the authorised representative of the Participant and must be submitted by May 22nd 2020 at the latest. Any registration form submitted beyond this date might not be considered by the Organiser. The Organiser will acknowledge the receipt of the Participant’s registration form within three (3) working days. If no receipt has been sent within three (3) days of submission, the Participant must contact the Organiser.

All invoices issued and sent to the Participant must be paid prior to the Event. The Organiser reserves the right to deny access the Participant to the Event if their accounts are not settled. A registration is not complete unless the payment of the full fee is made. The Participant must pay all bank charges and transfer charges.

To withdraw from the Event, in whole or in part, after signature and submission of the registration form, the Participant must notify the Organiser in writing by registered letter with acknowledgement of receipt. If the Participant withdraws from the Event before April 10th 2020, it will be held liable for thirty percent (30%) of the initial participation fee, to cover the Organiser's costs. Beyond this date, registration for the Event is definitive and irrevocable. The Participant will become liable for the full payment of the participation fees.

4/ ADMISSION, INSCRIPTION, PAIEMENT ET ANNULATION
